Conditions of Aircraft Rental

1. I will return the aircraft at the agreed time, weather permitting, and in the same condition.
2. I agree to pay the return cost to Eagle East Aviation if forced to leave it elsewhere for any reason other than mechanical.
3. I will call Eagle East Aviation in the event of any undue delay, deviation or any other unexpected circumstances and advise.
4. I will report all accidents, incidents, or damage, major or minor *immediately* to Eagle East Aviation. I will be responsible for any unreported damage, major or minor, discovered after my flight.
5. I agree to pay half of the time I schedule for failing to notify Eagle East Aviation of any cancellation at least 24 hours prior to my scheduled time (excluding illness or weather).

6. I will pay a minimum rental charge of at least half the scheduled time for bookings less than six (6) hours. I will pay a minimum charge of four (4) hours for any bookings over six (6) hours and up to one full day. For any additional fractions of a day I will pay for at least half of the additional scheduled time.
7. I agree to comply with the following requirements made to safeguard the aircraft and myself:
 - a. To inspect and make a ground check (preflight) of the aircraft before each flight, and not take off unless it is in airworthy condition.
 - b. To observe and obey all Federal, State, and local aviation regulations.
 - c. To fly only in daylight and in VFR conditions unless currently qualified under FAR 61.57(b) to fly at night, or currently qualified under FAR 61.57(c) or (d) to fly IFR.
 - d. To obtain weather reports and forecasts immediately before going cross-country, and to file a flight plan or itinerary with Eagle East Aviation and with the FAA prior to departure for ALL overnight flights and/or flights over 300nm. (NOTE: Any and all aircraft repairs away from Eagle East Aviation must be approved by Eagle East Aviation.) Flights to the Bahamas are PROHIBITED. I agree to be responsible for all services (fuel, oil, landing fees, etc.) not performed by Eagle East Aviation and I agree not to charge any services to Eagle East Aviation.
 - e. To permit no one else to fly the aircraft.
 - f. To land only at established airports except as a precautionary emergency measure.
 - g. To operate the aircraft within all FAA Part 91 Regulations.
 - h. Not to initiate a flight if the wind velocity exceeds, or is expected to exceed the maximum crosswind component for the aircraft and/or the pilot.
8. I agree to obtain liability coverage of at least \$100,000 and hull damage of at least \$20,000. I also understand that if the damages exceed these amounts, I may be held liable for the difference.
9. If I am planning on taking an aircraft overnight, I agree to provide Eagle East Aviation with a copy of my flight plan including runway lengths, forecast weather, and contact information.
10. If I am planning on taking an aircraft on a flight greater than 50 nm, I agree to provide Eagle East Aviation with a copy of my flight plan including runway lengths, forecast weather, and contact information.
11. If I have not flown at Eagle East Aviation within the past 90 days, I agree to be checked out by Eagle East Aviation personnel.
